The following described property:

That part of the Southwest Quarter of Section 14, Township 42 North, Range 12, East of the Third Principal Meridian, described as follows: beginning at the intersection of the East line of said Southwest Quarter with the North line of the South Half of the South Half of the Southeast Quarter of said Section 14; Thence Southwestwardly along a straight line a distance of 846.42 feet to an intersection with a line which is 27.81 chains East from and parallel with the West line of said Southwest Quarter of Section 14, which point of intersection is 7.74 chains, as measured along said parallel line, North of the South line of said Southwest Quarter; Thence Southwardly along the last described parallel line a distance of 7.74 chains (510.84 feet) to an intersection with said South line of the Southwest Quarter (being also the North line of the Northwest Quarter of Section 23); Thence Eastwardly along the North line of the Northwest Quarter of Section 23, a distance of 619.10 feet to the Westerly line of Waukegan Road; Thence Northwesterly along said Westerly line of Waukegan Road to its intersection with the Southerly line of the parcel of land conveyed by warranty deed recorded in the Recorder's Office of Cook County, Illinois, on August 17, 1928 as document 10122016; Thence Northeasterly along said Southerly line 455.53 feet, more or less, to the Southeast corner of parcel of land so conveyed which is on the East line of the said Southwest Quarter of Section 14 aforesaid; Thence North along the East line of said Southwest Quarter 187.41 feet to the point of beginning, in Cook County, Illinois.



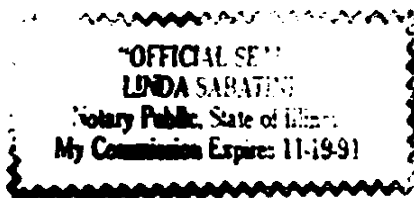
