Uniform Covenants, Borrower and Lendor covenant and agree as follows:

1, Payment of Principal and Interest; Propayment and Late Charges, Borrower shall promptly pay when due the principal of

and interest on the debt evidenced by the Note and any propayment and late charges due under the Note.

2. A, USE OF PROPERTY; COMPLIANCE WITH LAW, Borrower shall not seek, agree to or make a change in the use of the Property or its zoning classification, unless Londor has agreed in writing to the change.
