1. The amount of \$40,000.00 set forth in the third line of the first WHEREAS clause in the Mortgage is hereby deleted and the amount \$49,000.00 is hereby substituted in its place.
2. The date May 19, 1989, in the second line of the first WHEREAS clause in the Mortgage is hereby deleted and the date October 18, 1989 is hereby substituted in its place.

Except to the extent herein specifically supplemented, the Mortgage and all terms and conditions contained therein shall continue to be in full force and effect. Any reference to the Mortgage in any other document shall mean and include the Mortgage as supplemented hereby.

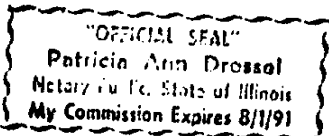
