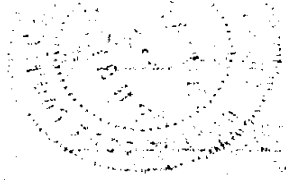

LEGAL DESCRIPTION PARCEL 4

That part of Lot 19 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 29th, 1988 as Document No. 88 598 270 described as follows: Commencing at the Northwest corner of said Lot 19; thence North 88 degrees 16 minutes 50 seconds East along the North line of said Lot 19 a distance of 69.23 feet for a place of beginning; thence continuing North 88 degrees 16 minutes 50 seconds East along the North line of said Lot 19 a distance of 17.01 feet; thence South 0 degrees 16 minutes 00 seconds West 127.60 feet to a point on a curve, being the Southerly line of said Lot 19; thence Southwesterly along the arc of said curve, being the Southerly line of Lot 19, being concave to the Southeast, having a radius of 55.00 feet, having a chord bearing of South 58 degrees 55 minutes 20 seconds West for a distance of 20.02 feet; thence North 0 degrees 16 minutes 00 seconds East 137.37 feet to the Place of Beginning; said parcel of land herein described contains 0.051 acres, more or less, in Cook County, Illinois.
