FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND COVENANTS,

- 1. Amended Plats of Survey. Pages 1, 3, 4 and 6 of the Plats of Survey attached to the Declaration as Exhibit "B" are hereby deleted and Pages 1, 3, 4 and 6 of the Plats of Survey attached to this First Amendment to Declaration are hereby substituted in lieu thereof.
- 2. Non-Modification. Except as expressly hereby amended, the Declaration remains unmodified.
