KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, Royal St. James, Ltd., a corporation originated under the laws of Illinois, P.O. Box 426, Palos Park, Illinois 60466 ("Mortgagor"), by Mortgage dated May 29, 1987 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on June 5, 1987 as document number 87305768, and by Assignment of Rents and Leases dated May 29, 1987 and recorded in the Office of the Recorder of Deeds of Cook County, Illinois on June 5, 1987 as document number 87305769 granted and conveyed unto Peoples Savings and Loan Association, F.A. (previously Peoples Bank for Savings) ("Lender") and its assigns, the premises therein particularly described ("Mortgaged Premises"), to secure the payment of the sum of three Million Five Hundred Thousand and 00/100 Dollars (\$3,500,000.00), with interest as therein set forth; and

NOW, THEREFORE, in consideration of the payment of ten and 00/100 Dollars (\$10,000) to the Lender by Mortgagor at the time of execution hereof, the receipt of which is hereby acknowledged, plus other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, Lender does remise, release, quitclaim and discharge from the lien and operation of said Mortgage and Assignment of Rents and Leases unto Mortgagor, and to the heirs and assigns of Mortgagor all that prime, parcel or tract of land being a part of the Mortgaged Premises commonly known as 11556 Autobahn Drive East, Palos Park, Illinois and legally described as follows:

ALL THAT PORT OF LOT 69 IN EDELWEISS IN THE PARK UNIT 2, BEING A SUBDIVISION OF PORT OF THE EAST HALF OF THE SOUTHEAST QUARTER OF SECTION 3A, TOWNSHIP 37 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN LYING SOUTH OF A LINE THAT IS DESCRIBED AS BEING 75.32 FEET NORTHERLY OF THE SOUTHWEST CORNER OF SAID LOT 69 (AS MEASURED ALONG THE WESTERLY LINE OF SAID LOT 69) AND 69.36 FEET NORTHERLY OF THE SOUTHEAST CORNER OF SAID LOT 69 AND BOUNDLED ALONG THE EASTERLY LINE OF SAID LOT 69, IN COOK COUNTY, ILLINOIS.


