WHEREAS, Assigned has agroud to make a loan (hereinafter referred to as the ((Loan") to Assignor, which Loan is evidenced by that certain Mortgage Note of even data he swith (heroinafter referred to as the "Note") made by Assignor and payable to the order of Assignor in the principal amount of ... ), including any amendments, modifications, extensions and renewals thereof and any supplemental note or 240,000.00 notes increasing such indebtedness and secured by, among other documents and instruments, that certain Mortgage, Assignment of Leases and Security Agreement of even date herewith (bineinafter referred to as the "Mortgage") made by Assignor to Assignee and recorded in the real estate records of Cook 1417-1419 N. Assignor, jointly and severally does hereby assign, transfer, set over and convey unto Assignee all o. Assignor's right, title and interest in, to and under (i) the leases, if any, as shown in Exhibit "B" attached hereto and incorporated by .e'..ence (hereinafter referred to as the "Identified Leases"), (ii) any and all leases, subleness or other tenancies, whether written or oral, which may now or at any time horeafter exist, whether or not the same are identified on Exhibit "B" attached hereto, and (iii) any and all amondments, modifications, extensions, renewals and replacements thereof, upon all or any part of the Premises (hureinafter collectively release to as the "Loases");

Together with any and all guaranties of tenants' performance under the Leus's;

Together with the immediately and continuing right to collect and receive all of the rents, income, receipts, revenues, issues, proceeds and profits (hereinafter referred to as the "Rents"), now due or which may heree ter become due or to which Assigner may now or may hereafter become entitled or which Assignor may demand or claim, including those Re us coming due during any redemption period, ansing or issuing from or out of the Leases or otherwise from or out of the premises or any part hereof, including but not limited to minimum rents, additional rents, percentage rents, deficiency rents and liquidated damages following default, and all proceeds physible under any policy of insurance covering loss of rents resulting from unlenantability due to destruction of camage to the Premises, and all escrow accounts or security deposit accounts, together with any and all rights and claims of any kind that Assignor may have against any tenant under the Leases or any subtentants or occupants of the Premises;

To have and to hold the same unto the Assignee, its successors and assigns, until termination of this Assignment as hereinafter provided; Subject, however, to the right hereby granted by Assignee to Assignor to collect and receive the Ren.s prior to the occurrence of a default herounder; provided, however, that this right is limited as hereinafter set forth.

In order to protect the security of the Assignment, Assignor covenants and agrees as follows:

1. Assignor's Representation and Warranties Concerning Leases and Rents. Trustee represents and the Concerning Leases and Rents. warrants, if Property is vested in a land trust as of the date hereof and as of all dates hereafter, that:

(a) Assignor has good title to the Leases and Rents hereby assigned and good right and authority to design them, tree from any act or other instrument that might limit Assignor's right to make this Assignment or Assigned's rights hereunider, and no other person, firm or corporation has any right, title or interest therein,

(b) Assignor has duly and punctually performed all the terms, covenants, conditions and warranties of the Lusses that were to be kept, observed and performed by it;
(c) The Identified Leases and all other existing Leases are valid, unamended and unmodified and in full force and effect:

(d) Assignor has not previously sold, assigned, transferred, mortgaged, or pledged the Rents from the Premises, whether they are due now or to become due hereafter;

(a) Any of the Rents due and issuing from the Premises or from any part thereof for any period subsequent to the date hereof have not been collected, and payment thereof has not otherwise been anticipated, abated, concoded, waived, released, discounted, set off or compromised;

(f) Assignor has not received any funds or deposits from any tenant for which credit has not already been made on account of accrued rents. This paragraph does not apply to security deposits.

(9) The tonants under the Identified Leases and all other existing leases are not in default of any of the terms theref Assignor's Covenants of Performance. Assignor covenants and agrees to:

(a) Observe, perform and fulfill, duly and punctually, all the obligations, terms, covenants, conditions and warranties of the Note, Mortgage, other Loan Documents and the Leases that Assigner is to keep, observe and perform, and give prompt notice to Assigner of any failure on the part of Assigner to observe, perform and discharge the same;

(b) Give prompt notice to Assignee of any notice, demand or other document received by Assignor from any tenunt or subtenant

under the Leases specifying any default claimed to have been made by the Assigner under the Leases:

(c) Enforce or secure the performance of each and every obligation, term, covenant, condition, and warranty in the Leases to be performed or fulfilled by any tenant, and notify Assignou of the occurrence of any default under the Lorens.

(d) Appear in and defend any action or proceeding arising under, occurring out of, or in any manner connected with the Leases. or the obligations, duties or habilities of Assignor and any tenant thereunder;

(e) Pay all costs and expenses of Assignee, including attorneys' fees, in any action or proceeding in which Assignee may appear in connection herewith; and

(f) Neither create nor permit any lien, charge, or encumbrance upon its interest in the Premises, Leases or Rents, or as Leases of the Loases, except for the lien of the Mortgage or as provided in the Mortgage.

(b) Walve, excuse, condone, abate, concede, discount, set off, compromise or in any manner release or discharge any tenant under any of the Leases of and from any obligation, covenant, condition or warranty to be observed, performed or fulfilled by the tenant.
