THE REVENUE ACCOUNTS FOR THE YEAR ENDING DECEMBER 31, 1987, SHOW A TOTAL REVENUE OF \$1,000,000,000. THIS IS AN INCREASE OF 5% OVER THE REVENUE OF \$950,000,000 FOR THE YEAR ENDING DECEMBER 31, 1986.
