WHEREAS, part of the first part is willing to so amend said Installment Note, subject, however, to the terms, covenants, and conditions hereinafter set forth:

WHEREAS, part of the second part are desirous of amending the terms of said Installment Note to extend the date on which the final payment of principal and interest shall be due and payable to ~~March 13,~~ <sup>APRIL 13,</sup> 1990, and

WHEREAS, the unpaid principal balance of said Installment Note, as of the date hereof, is the sum of Eighty Two Thousand and no/100 Dollars (\$82,000.00); and

WHEREAS, said Installment Note, secured by said Trust Deed, provides that parties of the second part "promise to pay the principal sum of Eighty Five Thousand and no/100 Dollars and interest from September 30, 1986 on the balance of principal remaining from time to time unpaid at a rate of 11.00%"; and

WHEREAS, the party of the first part is the legal owner and holder of that certain Installment Note, executed by parties of the second part, in the principal sum of \$85,000.00, payable to THE WINNETKA BANK and dated September 30, 1986, which said Installment Note is secured by Trust Deed dated September 30, 1986, recorded in the Office of the Recorder of Deeds of Cook County, Illinois, as Document Number 86549284, conveying the following described property, to-wit:

Lot 9 in Junipers' Forest Subdivision of the south 15 rods of the Southeast quarter of the Southwest Quarter of Section 31, Township 42 North, Range 13, East of the Third Principal Meridian in Cook County, Illinois, and also known as lot 16 in the County Clerk's Division of Section 31.

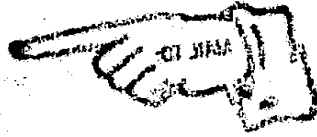

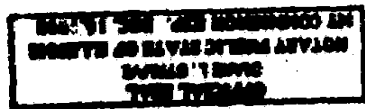

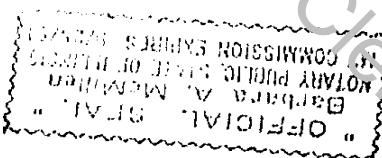
