## EXHIBIT A

### LEGAL DESCRIPTION PARCEL 3

That part of Lot 10 in Wellington Court, being a Subdivision of part of the West Half of the Northwest Quarter of Section 33, Township 41 North, Range 10 East of the Third Principal Meridian, according to the Plat thereof recorded December 29th, 1988 as Document No. 88 598 270 described as follows: Commencing at the most Southerly corner of said Lot 10; thence North 36 degrees 40 minutes 00 seconds West along the Southwesterly line of said Lot 10 a distance of 50.61 feet for a place of beginning; thence continuing North 36 degrees 40 minutes 00 seconds West along the Southwesterly line of said Lot 10 a distance of 17.00 feet; thence North 53 degrees 24 minutes 20 seconds East 170.00 feet to a point on the Northeasterly line of said Lot 10; thence South 36 degrees 40 minutes 00 seconds East along the Northeasterly line of said Lot 10 a distance of 17.00 feet; thence South 53 degrees 24 minutes 20 seconds West 170.00 feet to the Place of Beginning; said parcel of land herein described contains 0.066 acres, more or less, in Cook County, Illinois.
