OAK FOREST PARK OFFICIAL BUSINESS RDINANCE ANNEXING TO THE OAK FOREST PARK DUSTRIANT BUSING IN COOK COUNTY, ILLINOIS, PROPERTY WITHIN THE CITY OF OAK FOREST NOT PREVIOUSLY IN SAID PARK DISTRICT, WHICH PROPERTY IS DESCRIBED IN THIS ORDINANCE AND LIES WHOLLY WITHIN THE COUNTY OF COOK AND STATE OF ILLINOIS

WHEREAS, Section 3-10 of Chapter 105 of the Revised Statutes of 1985 provides that a Park District may annex by Ordinance all that territory within a City or Village in which said Park District operates; and

WHEREAS, the Commissioners of the Oak Forest Park , Cook County, Illinois, have considered the question of District. annexation of the territory hereinafter described and have determined that said territory is within the City of Oak Forest, Cook County, Minois, and is contiguous to the territory of the Oak Forest Park District of Cook County, Illinois, and that the residents thereof carrently use the facilities of said Park District and will in the future use and need additional facilities in such areas for recreation and park purposes;

WHEREAS, it is to the best interests of all of the residents of said Park District and to the best interests of the residents, the voters and owners of the territory hereinafter described to become a part of the Cak Forest Park District.

BE IT ORDAINED by the Commissioners of NOW THEREFORE, the Oak Forest Park District as follows:

SECTION 1

hereinafter described, That the territory territory described in this Ordinance, and specifically by reference of the Oak Forest Park District of Cook County, Illinois, and not within said Fark District, or any other Park District, and within the provisions of Chapter 105, Section 3-10 of the Illinois Revised Statutes of 1985 be and the same is hereby annexed to the Oak Forest Park District, Cook County, Illinois, in accordance with the provisions of said Chapter 105, Section 3-10 of the Revised Statutes of Illinois. The territory hereby annexed, as shown by the shaded areas on the maps hereto attached, which are made a part of this Ordinance, is known and described as follows, to wit:

> The West 435.00 feet of that part of the East 80 rods of the East 1/2 of the Southeast 1/4 of Section 22, lying South of the South line of Arthur T. McIntosh and Company's Southtown Farms Unit #7, a Subdivision of the North 120 rods of the East 80 rods of the Southeast 1/4of Section 22, Township 36 North, Range 13,

East of the Third Principal Meridian, South of the Indian Boundary Line, in Cook County, Illinois, also, Lot 21 in said Arthur T. McIntosh and Company's Southtown Farms Unit #7, all in Cook County, Illinois.

and which said tract of land above described and in the attached descriptions intended to be all in the territory within the City limits of the City of Oak Forest not previously included within the Oak Forest Park District.

SECTION 2

This Ordinance shall take effect and be in full force and effect from and after its passage and approval according to law and after filing of a certified copy of this Ordinance and the map attached hereto, in the Office of the Recorder of Deeds and Clerk of the Circuit Court of Cook County, Illinois, as provided by law.
