Parcel 1: The North 60 feet of the West 1/2 (except the West 286.07 feet thereof) of Lot 6 in Hunter's Subdivision of the Northwest 1/4 of Section 31, Township 38 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

Parcel 2: All that part of the North 1/2 of the West 1/2 of Lot 6 in Hunter's Subdivision of the Northwest 1/4 of Section 31, Township 38 North, Range 14, East of the Third Principal Meridian, lying Northeasterly of the following described curve 1 line:

Commercing at a point in the South line of the North 1/2 of said Lot 6, a distance of 342.03 feet West of the East line of the West 1/2 of Lot 6; Thence Northwesterly on a curved line convex Southwesterly and having a radius of 359.26 feet, a distance of 359.41 feet to the Northwest corner of said Lot 6 aforesaid and lying East of the East line of the West 236.07 feet and South of the South line of the North 110 feet of Lot 6 aforesaid, in Cook County, Illinois.
