MEMORANDUM OF LEASE AND COLLATERAL ASSIGNMENT OF LEASE

KNOW ALL MEN BY THESE PRESENTS, that Harper Court Foundation, Inc., as Lessor, has entered into a lease agreement dated December 23, 1988 (hereinafter referred to as "Lease") with The New Tentsuna Restaurant, Inc., an Illinois corporation (hereinafter referred to as "New Tentsuna"), Lessee, pertaining to the improved real estate commonly known as Space Cl09, 5225 S. SAID COLLATERAL ASSIGNMENT secures indebtedness evidenced by a promissory note dated December 23, 1988, made by NEW TENTSUNA, payable to the order of Tentsuna Corporation, in the principal sum of 2018/50, payable as provided in said note, with the remaining balance of principal and interest due on or before February 17, 1989.
