EXPENDITURES BY LENDER. Any amount that Lender expends in so doing will bear interest at the rate charged under the Note from the date incurred or paid by Lender to the date of repayment by Grantor. If such a failure is curable and if Grantor or Borrower has not been given a notice of a breach of the same provision of this Assignment within the preceding twelve (12) months, it may be cured (and no Event of Default will have occurred) if Grantor or Borrower, after receiving written notice from Lender demanding cure of such failure: (a) cures the failure with fifteen (15) days; or (b) if the cure requires more than fifteen (15) days; immediately initiates steps sufficient to cure the failure and thereafter continues and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Breaches. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor or Borrower under this Assignment, the Note or the Related Drouments is, or at the time made or furnished was, false in any material respect.

Compliance Default. Fallule of Grantor or Borrower to comply with any other term, obligation, covenant, or condition contained in this Assignment, the Note, or in any other agreement between Grantor or Borrower and Lender.

Insolvency. The insolvency of Granter or Borrower, appointment of a receiver for any part of Granter or Borrower's property, any assignment for the benefit of creditors, the commencement of any proceeding under any bankruptcy or insolvency laws by or against Granter or Borrower, or the dissolution or termination of Granter or Borrower's existence as a going business (if Granter or Borrower is a business).
