- 5. The Lienor furnished store fixtures to Karen Austin Petites consisting of metal fixtures, garment fixtures and glass units which were, upon information and belief, installed in the Karen Austin Petites store in the building of the owner.
- The name and address of the owner of the real property is LaSalle National Bank, as Trustee under the provisions of a trust agreement dated the 1st day of March, 1984 known as Trust Number 107701. The address of the Trustee is 135 South LaSalle Street, Chicago, Illinois.
- The property subject to the lien claim is situated at 900 N. Michigan Avenue, Chicago, Illinois, in the County of Cook, which property is described on Exhibit A annexed hereto.

### LEGAL DESCRIPTION

900 North Michigan Avenue Chicago, Illinois
