Saul Strober, being duly sworn, hereby deposes and says:

1. This Affidavit is made in accordance with Chapter 82, Par. 7 of the Illinois Revised Statutes, which governs Mechanics' Liens.

2. I am the Secretary of Ferro Merchandising Equipment Corp. (the "Lienor"), a New Jersey corporation with offices at 690 Wainwright Street, Union, New Jersey 07083. The Lienor is also the original contractor.

3. The Lienor furnished materials to, and was employed by, Petite Concepts Ltd. d/b/a Karen Austin Petites, Inc., the owner's lessee.

4. The Lienor furnished materials to the Karen Austin Petites store at 900 North Michigan Avenue, Chicago, Illinois, on or about September 30, 1988. The agreed upon price and value of all material furnished is \$23,597.85 of which amount \$23,597.85 remains due and unpaid.

5. The Lienor furnished store fixtures to Karen Austin Petites consisting of metal fixtures, garment fixtures and glass units which were, upon information and belief, installed in the Karen Austin Petites store in the building of the owner.

6. The name and address of the owner of the real property is LaSalle National Bank, as Trustee under the provisions of a trust agreement dated the 1st day of March, 1984 known as Trust Number 107701. The address of the Trustee is 135 South LaSalle Street, Chicago, Illinois.

7. The property subject to the lien claim is situated at 900 N. Michigan Avenue, Chicago, Illinois, in the County of Cook, which property is described on Exhibit A annexed hereto.





LEGAL DESCRIPTION

900 North Michigan Avenue
Chicago, Illinois

That part of Lots 3, 4, 9 and 10 lying West of the West line of North Michigan Avenue (formerly Pine Street) in Block 13 in the Subdivision by the Commissioners of the Illinois and Michigan Canal of the South fractional quarter of Section 3, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

ALSO: Lots 2, 3 and 4 in Kinzer's Subdivision of Lots 13, 14 and 15 in Block 13 in the Subdivision by the Commissioners of the Illinois and Michigan Canal of the South fractional quarter of Section 3, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

ALSO: A strip of land 20 feet wide East and West, formerly alley and now vacated, lying West of and adjoining aforesaid Lot 4 in Kinzer's Subdivision.

ALSO: That part of Lot 2 in Block 13 in the Subdivision by the Commissioners of the Illinois and Michigan Canal of the South fractional quarter of Section 3, Township 39 North, Range 14, East of the Third Principal Meridian, lying East of a line described as follows: commencing at a point in the South line of Lot 2, aforesaid, 129 feet East from the Southwest corner of said Lot; thence North 45 feet, more or less, to the North line of said Lot 2; and lying West of the West line of Lot 1 in Breit's Subdivision of Lots 1 and 2 in Block 13 in the Subdivision by the Commissioners of the Illinois and Michigan Canal of the South fractional quarter of Section 3, Township 39 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.
