PARTIAL RELEASE DEED

KNOW ALL MEN BY THESE PRESENTS, that Harris Trust and Savings Bank, an Illinois banking corporation, in consideration of one dollar, and other good and valuable considerations, the receipt whereof is hereby acknowledged, does hereby release, all the right, title, interest, claim or demand whatsoever it may have acquired in, through or by that certain Mortgage and Security Agreement with Assignment of Rents dated June 20, 1988 and recorded July 1, 1988 as Document No. 88289608 as amended by Mortgage Amendment recorded September 2, 1988 as Document No. 88401454 (the "Mortgage") in the premises described below, situated in the County of Cook, State of Illinois, as follows, to wit:

Unit 3008-8 in Harvest Run Condominium, as delineated on the survey of the following described Real Estate: That part of the Harvest Run subdivision being a part of the Northwest 1/4 of the Southeast 1/4 of Section 12, Township 42 North, Range 10 East of the Third Principal Meridian in Cook County, Illinois, which survey is attached as Exhibit "A" to the Declaration of Condominium, recorded as Document No. 88476474 together with its undivided Percentage Interest in the Common Elements.
