

Excerpts From Internal Revenue Code

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to gay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty together with any costs that may accrue in addition thereto) a shall be a lien in tevor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically lixed by law, the lien imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpayer arising out of such (lability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. \$23. Validity and Priority Against Certain Persons.

(a) Eurchaser's, Holders Of Security Interest Mechanic's Lienors, And Judgment Lien Greditors. — The lien imposed by section 6321 shall not be and as against any purchaser, holder of a security interest achanic's liener, or judgment lien creditor until notice thereof (fich meets the requirements of subsection (I) has been filed by the Secretary.

in Place For Filling Notice: Form .-

(1) Place For Filing . The notice referred to in subsection (2) shall be filed -

(A) Under State Laws

(I) Real Property - In the case of real property, in one office within the State for the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the ilen is situated; and

(ii) Personal Property - In the case of personal property, whether tangible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such Slate, in which the property subject to the lien is situated;

(B) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia - In the office of the Recorder of Deeds of the District of Columbia offthe property subject to the Item is situated in the District of Columbia.

(2) Situs 01 Property Subject To Lien - For purposes of paragraphs (1) and (4), property shall be deemed to be situated -(A) Real Property - In the case of real property, at its unvisical location; or ::

(8) Personal Property - In the case of personal property, whether tangible or intangible, at the residence of the expayer at the time the notice of tien is filled.

For purpor as of paragraph (2) (B), the residence of a corporation or parine this tall be deemed to be the place at which the principal executive of ice of the business is located, and the residence of a tax?..... whose residence is without the United States shall be deem id to be in the Olstrict of Columbia.

(3) Form - The firm and content of the notice referred to in subsection (a) shall be prescribed by the Secretary. Such notice shall be raild notwithstanding any other provision of law regarding the form or content of a notice of iten.

(a) Refilling Of Notice. — For purposes of this

(1) General Rule. - Unless notice of then is refilled in the manner prescribed in paragraph (2) during the required tellling period, such notice of then shall be treated as filed on the date on which it is filed (in accordance with subsection (f)) after the expiration of such retiling period.

(2) Place For Filing. - A notice of then refiled during the required reflling period shall be effective only -

(i) such notice of lien is refiled in the office in which the (A) if -

prior notice of tien was filed, and (ii) in the case of real property, the fact of refilling is entered and recorded in an index to the extent required by subsection (f) (4), and

(8) in any case in which, 90 days or more prior to the date of a refilling of notice of lien under subparagraph (A), the

Secretary received written information (in the manner, prescribed in regulations issued by the Secretary) concerning a change in the taxpayer's residence, if a notice of such tien is also filed in accordance with subsection (f) in the State in which such residence is located.

(3) Required Refilling Period. — in the case of any notice of ilen, the term "required refiling period" means -(A) the one-year period anding 30 days after the expiration. of 6 years after the date of the assessment of the tax, and (B) the one-year period ending with the expiration of 6 years after the close of the preceding required reliting period for such notice of lien.

Release Of Lien Or Sec. 6325. Discharge Of Property.

(a) Release Of Lien, - Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any flor imposed with respect to any internal revenue tax not later than 30 days after the day on

(1) Liability Satisfied or Unanforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has

recome legally unenforceable; or

(2) Bond Accepted - There is furnished to the Secretary and acre, tell by him a bond that is conditioned upon the payment of the Enount arressed, together with all interest in respect thereof, vithin he time prescribed by law (including any extension of source (ine), and that is in accordance with such requirements relating to terms, conditions, and form of the bond and sureties thereon, as may be specified by such regulations.

(k) Disclosure: of Certain Returns and Return Information For Tax Administration Purposes. -

(2) Disclosure of amount of purstanding lion. - If a notice of lien has been filed pursuant to section 6323(f). The amount of the outstanding obligation secured by such lien may be disclosed to. any person who furnishes satisfactory written evidence that he has a right in the property subject to such tien or intends to obtain a right in such property
