That part of Block 3 in the Assessor's Division of the Kingsbury Tract, in the East 1 of the North West 1 of Section 9, Township 39 North, Range 14 East of the Third Principal Meridian, lying Easterly of the East Dock Line of the North Branch of the Chicago River; lying Southwesterly of the Southwesterly line of Kingsbury Street, lying South and Southeasterly of the following described line:
