- 3) This agreement is supplementary to said Mortgage, Note, and Homeowner's Reserve Loan Agreement the ("Loan Documents"). All the provisions thereof, including the right to declare principal and accrued interest due for any cause specified in said Loan Documents, shall remain in full force and effect except as herein expressly modified. The Owner agrees to perform all the covenants of the grantor or grantors in said Mortgage. The provisions of this indenture shall inure to the benefit of any holder of said Agreement and Note and shall bind the heirs, personal representatives and assigns of the Owner.
