THIS INDENTURE, made JANUARY 24th 19 89, between MARGARET LOUISE TAYLOR BINION,

DIVORCED AND NOT SINCE REMARRIED.

herein referred to as "Mortgagors," and SECURITY PACIFIC FINANCIAL SERVICES, INC. A DEL. AWARE, xxx an Minors corporation, herein referred to as TRUSTEE, witnesseth:
