The parties hereto have caused these presents to be signed in three counterparts by their respective officers and principles the day first above written.

TO HAVE AND TO HOLD TO SAID GRANTEE SAID EASEMENT THROUGH, OVER, ALONG AND ACROSS SAID DESCRIBED LANDS FOR THE PURPOSE OF THE CONSTRUCTION, INSTALLATION, AND MAINTENANCE OF A SIX INCH (6") SANITARY SEWER AS MARKED NO. 2 AND SHOWN ON WHITE PRINT LC49-01A DATED 1-1-89 AND ATTACHED HERETO AS EXHIBIT A.

A 10.00 FOOT EASEMENT LYING 5.00 FEET EITHER SIDE OF THE FOLLOWING DESCRIBED LINE: THAT PART OF THE SOUTH 175.00 FEET OF THE SOUTHWEST 1/4 OF SECTION 21, TOWNSHIP 38 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS: COMMENCING AT THE SOUTHWEST CORNER OF THE SOUTHWEST 1/4 OF SECTION 21; THENCE NORTH 90 WEST ALONG THE SOUTH LINE OF SAID SOUTHWEST 1/4, 280.42 FEET TO THE POINT OF BEGINNING; THENCE NORTH 15-48'-52" EAST, 181.88 FEET TO THE NORTH LINE OF THE SOUTH 175.00 FEET OF SAID SOUTHWEST 1/4 AND THERE TERMINATING.

EASEMENT NO. 2

THAT for and in consideration of the sum of ten dollars, the receipt of which is hereby acknowledged and in consideration of the promises made and referenced in the grant of easements recorded March 30 1988 as document 88130911 in Cook County, Illinois, said grantor and grantee agree to modify and amend Easement No. 2 as contained in said grant of easements by deleting the two paragraph language describing Easement No. 2 from the original grant of easements, and in its place inserting the following as Easement No. 2:

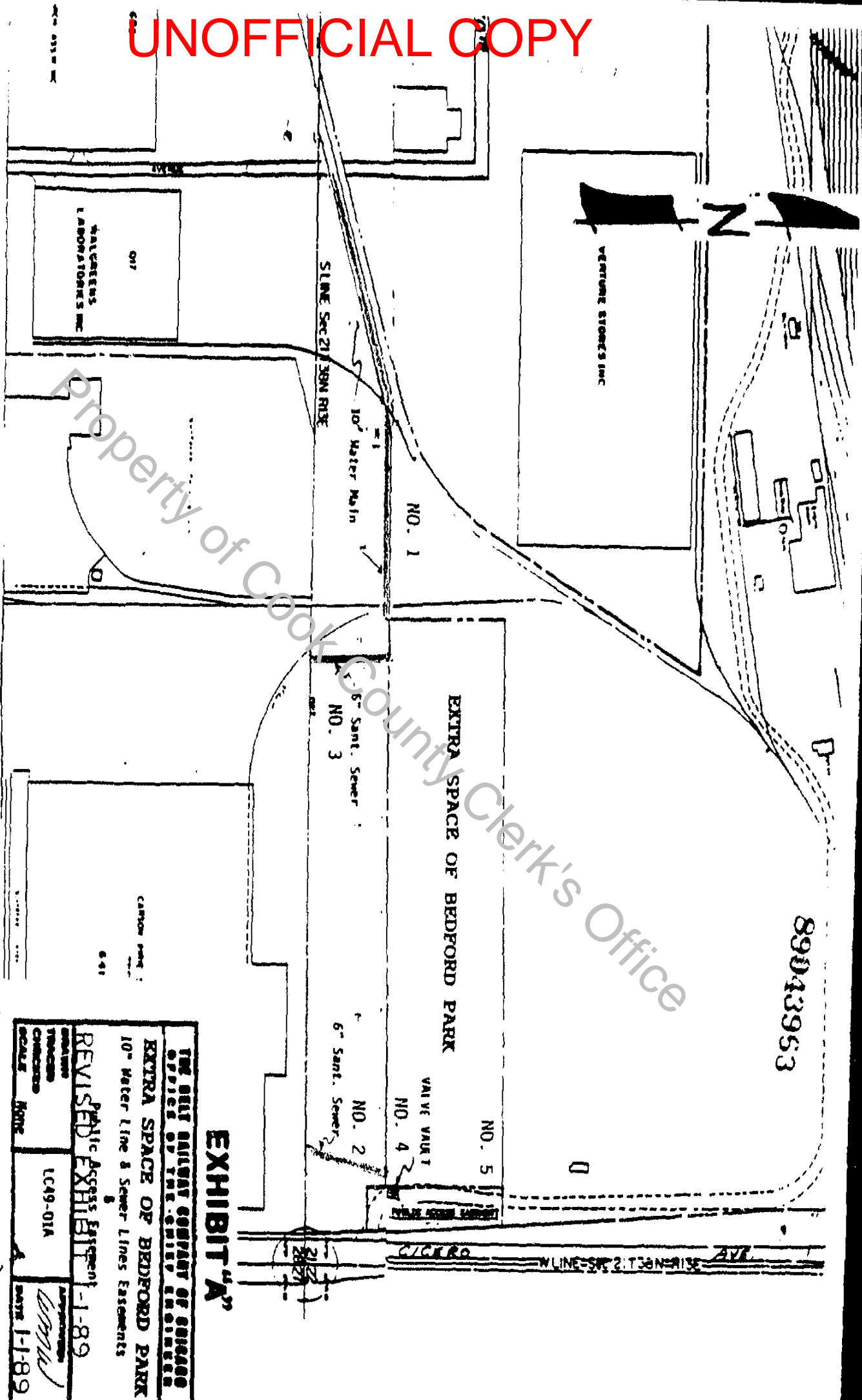
