ASSIGNMENT OF RENTS

The undersigned represents and agrees that or rents have been or will be paid by any person in possession of any portions in the fremises for more than one installment in advance and that the payment of rooms has not been or will not be waived, released, reduced or discounted or otherwise discharged or comparemised by the undersigned. The undersigned waived into right of set-off against any person in possession of any partion of the Premises. The undersigned agrees that the undersigned will not further assign any of the rents, increase or profits of the Premises except with the prior written consent of Assignee.

Nothing herein contained shall be construed as constituting Assignee a "rortgagee in possession" in the absence of the taking of actual possession of the Premises by Assignee pursuant to the provisions bereinsflee contained. In the exercise or the powers herein granted Assignee, no liability shall be asserted or enforced against Assignee, all such liability being expressly wasved and released by the undersigned.

The undersigned further agrees to assign and transfer to Assigner all existing and future leases upon all or any part of the Premises and to execute and deliver, immediately upon the request of Assignee, all such further assurances and assignments as Assignee shall from time to time require.

Assignee has a right to institute foreclosure proceedings, whether before or arter the Liabilities are declared to be immediately due or upon expiration of notice and grace periods, if any, whether before or after institution of legal proceedings to foreclose the lien thereof, or before or after sale thereunder, intediately upon demand of Assignee, the undersigned agrees to surrender to assignee and Assignee shall be entitled to take actual possession of the Premises or any part thereof personally, or by Assignee's agents or attorneys, and Assignee in Assignee's discretion may, with or without force and with or without process of law, enter upon and take and maintain possession of all or any part of the remises, together with all the documents, books, records, papers and accounts of the undersigned, or then owner of the Premises relating thereto, and may builtude the undersigned, the undersigned's agents or servarts, wholly therefrom and may as attorney-in-fact or agent of the undersigned or in Assignee's own name and under the powers herein granted, hold, operate, manage and control the Premises and conduct the business, if any, thereof either personally or by Assignee's agents or attorneys, with full power to use such measures, legal or equitable, as in Assignee's discretion or in the discretion of Assignee's successors or assigns may be deemed proper or necessary to enforce the payment of security of the avails, rents, issues and profits of the Premises, including actions for the recover, of rent, accions in forceable detailer and actions in discress of rent. The undersigned grants Assignue full power and authority to chercise each and every on the rights, privileges and powers herein granted at any and all times herentter, without notice to the encersighed, and tith full power to cancel or terminate any lease or subtesse for any cause or in any ground which would entartle the taldireigned to cancel the same, to elect to disaffirm any lease or sublease made a bacquent to the aforessed Horizage or subordinates to the lien thereof. The ordersigned hereby grants Assignee the full power and authority to insure and reincute the Premises for all tisks, incliental to Assignee's possession, operation and management thereof and to receive all such avails, ments, issues and profits.

Assignee shall not be obligated to perform or discharge, nor does Assigned northly undertake to perform or discharge, any obligation, duty or liability under any lesses or rental agraements relating to the Prendsas, and the undersigned shall and does horeby agree to indemnify and hold Assignee haveless of and from any and all liability, loss or damage which Assignee may or might incur under any such lesses or agreements or under or by reason of the assignment thereof and of and from any and all claims and demands whatsoever which may be asserted against Assignee by reason of any alleged obligations or undertakings on Assignee's part to perform or discharge any of the terms, covenants or agreements contained in said leases or agreements or in the defense of any claims or demands arising prior to Assignee taking possession of the

Premises. The undersigned hereby agrees to immediately reimburse Assignee upon demand for any amount due Assignee by reason of this paragraph, including costs, expenses and legal fees incurred by Assignee.

Assignee, in the exercise of the rights and powers conferred upon Assignee by this Assignment of Rents, shall have full power to use and apply the avails, rents, issues and profits of the Premises to the payment of or on account of the following, in such order as Assignee may determine.

- (a) To the payment of the operating expenses of the Premises, including the cost of management and leasing thereof (which shall include reasonable compensation to Assignee and Assignee's agent or agents, if management be delegated to an agent or agents, and it shall also include lease commissions and other compensation and expenses of seeking and procuring tenants and extring into leases) to establish reserves for claims for damages, if any, and premiums on insurance hereinabove authorized.
- (b) To the payment of taxes and special assessments now due or which may hereafter become due on the Premises.
- (c) To the payments of all repairs, decorating, renewals, replacements, alteration, additions or betterments and improvements of the Premises, including the cost from time to time of installing, replacing refrigeration, say or electric appliances therein, and of placing the Premises in such condition as will, in the judgment of Assignee, make it readily remarkle;
- (d) To the payment of any Lizotities (first to interest and then to principal).

The undersigned does further specifically surborize and instruct each and every present and future lesses or tendet of the Phole or any part of the Premiser to pay all uppard rental agreed upon in any tenancey to Assignee upon receipt of demand from Assignee to so pay the same.

Liabilities also includes all costs of collection, legal expanses and attempting fees incurred or paid by Assignee in attempting the collection or enforcement of the aforesald Note, any gerranty of the aforesald Note, or any other indebtedness of the undersigned or any guarantor of the aforesaid Note to assigned or in the repossession, custody, sale, lease, assembly or other disposition of any collateral for the aforesaid Note. Liabilities includes all of the indebtedness or contractual duties of partnerships to Assignee created or arising while the undersigned or any guarantor of the aforesaid Note may have been or may be a member of those partnerships.

It is understood and agreed that the provisions set forth in this Assignment herein shall be deemed as a special remedy given to Assignee, and shall not be deemed exclusive of any of the remedies granted in the above described Mortgage, but shall be deemed an additional remedy and shall be cumulative with the remedies granted therein.

Whenever the word "undersigned" is mentioned herein, it is hereby understood that the same includes and shall be binding upon successors and assigns of the undersigned, and any party or parties holding title to the Premises by, through or under the undersigned. All of the rights, powers, privileges and immunities herein granted and assigned to Assignee shall also inure to Assignee's successors and assigns, including all holders, from time to time, of the aforesaid Note.

It is expressly understood that no judgment which may be entered on any debt secured or intended to be secured by the above described Mortgage shall operate to abrogate or lessen the effect of this instrument, but that the same shall continue in fill force and effect until the payment and discharge of any and all of the Liabilities and all bills incurred by virtue of the authority contained herein have been fully paid out of the rents, issues and profits of the Premises, or by the undersigned, or intil such time as this instrument may be voluntarily released by assignee. This instrument shall also remain in full force and effect during the pendancy of any fereclosure proceedings, both before and after sale, until the issuance of a deed pursuant to a forcelosure decree, unless the Liabilities are fully eatisfied before the expiration of any applicable period of redemption.

This Assignment of Rents has been made, executed and delivered to Assignce in Cook Councy, Illinois and shall be construed in accordance with the laws of the State of Illinois. Wherever possible, each provision of this Assignment of Rents shall be interpreted in such manner as at be effective and valid under applicable law. If any provisions of this Assignment of Rents are prohibited by or determined to be invalid under applicable law, such provisions shall be ineffective to the extent of such prohibitions or invalidately, without invalidating the remainder of such provisions or the immaining provisions of this Assignment of Rents.
