AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS, HEREINAFTER DESCRIBED, IS IN THE PUBLIC INTEREST AND IN THE BEST INTERESTS OF THE VILLAGE OF GLENVIEW, AND WILL PROMOTE THE PUBLIC HEALTH, SAFETY AND WELFARE OF THE VILLAGE AND ITS RESIDENTS; AND

PLAT WITH THIS DOCUMENT

WHEREAS, the corporate authorities of the Village of Glenview, have determined that annexation of certain territory in Cook County, Illinois, hereinafter described, is in the public interest and in the best interests of the Village of Glenview, and will promote the public health, safety and welfare of the Village and its residents; and

WHEREAS, the corporate authorities of the Village of Glenview, a home rule municipality, find that the following described territory is unincorporated territory containing less than 60 acres, and is wholly bounded by the Villages of Glenview and Northbrook.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2: The unincorporated territory, containing less than 60 acres and wholly bounded by the Villages of Glenview, and Northbrook, and is legally described as follows:

That part of the Southeast 1/4 of the Northeast 1/4 of Section 21, Township 42 North, Range 12, East of the Third Principal Meridian and that part of the Southwest 1/4 of the Northwest 1/4 of Section 22, Township 42 North, Range 12, East of the Third Principal Meridian, described as follows: Beginning at the point of intersection of the South line of the Northeast 1/4 of said Section 21 with the Southeasterly Right Of Way line of the Chicago and Northwestern Railroad (Formerly the Des Plaines Valley Railroad); Thence Westerly along the South line of said Northeast 1/4 to an intersection with the Northwesterly Right Of Way line of said Chicago and Northwestern Railroad; Thence Northeasterly along said Northwesterly Right Of Way line to an intersection with the East line of Shermer Road as widened; Thence Northerly along said East line of Shermer Road as widened to an intersection with the Westerly extension of the South line of Willow Road; Thence Easterly along said Westerly extension and along said South line of Willow Road to an intersection with the Southeasterly Right Of Way line of said Chicago and Northwestern Railroad; Thence Southwesterly along said Southeasterly Right Of Way line to the place of beginning, in Cook County, Illinois. (Except that part of the Chicago and Northwestern Railroad.)

Section 3: The Clerk of the Village of Glenview is hereby authorized and directed to record with the Recorder of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an accurate map of the territory annexed, attached hereto and made a part hereof and a document of annexation shall be filed with the County Clerk and the County Election Authority.
