THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, the corporate authorities of the Village of Glenview, have determined that annexation of certain territory in Cook County, Illinois, hereinafter described, is in the public interest and in the best interests of the Village of Glenview, and will promote the public health, safety and welfare of the Village and its residents; and

WHEREAS, the corporate authorities of the Village of Glenview, a home rule municipality, find that the following described territory is unincorporated territory containing less than 60 acres, and is wholly bounded by the Village of Glenview.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2: The unincorporated territory, containing less than 60 acres and wholly bounded by the Village of Glenview, and is legally described as follows:

That part of Section 37, Township 42 North, Range 12, East of Third Principal Meridian described as follows: Beginning at the most northerly northwest corner of Lot 1 in Leonard W. Schultz Subdivision, according to the plat thereof recorded December 10, 1984 as Document No. 27366646, said point of beginning being on the southerly line of West Lake Avenue; Thence southerly along a westerly line of said Lot 1, 99.67 feet to a corner of said Lot 1; Thence southwesterly along a northwesterly line of said Lot 1, 144.70 feet to the most westerly corner of said Lot 1, said point being on the northeasterly line of Milwaukee Avenue; Thence northwesterly along said northeasterly line of Milwaukee Avenue to an intersection with a line drawn perpendicular to the southwesterly line of Milwaukee Avenue from the point of an intersection of said southwesterly line of Milwaukee Avenue with a line 95.00 feet, as measured along the center line of Milwaukee Avenue, southerly of and parallel with the north line of Lot 3 in Superior Court Partition, according to the plat thereof recorded November 10, 1892 as Document No. 2892192; Thence southwesterly along said last described perpendicular line, 128.27 feet to the aforesaid point of intersection on the southwesterly line of Milwaukee Avenue; Thence westerly along said line parallel with the north line of Lot 3 in Superior Court Partition, aforesaid 198.26 feet to an intersection with a line 219.27 feet, as measured along said last

described parallel line westerly of the intersection of said parallel line the center line of Milwaukee Avenue; Thence northwesterly along said last described line parallel with the center line of Milwaukee Avenue, 223.01 feet to the northerly line of West Lake Avenue; Thence westerly along said northerly line of West Lake Avenue to the most southerly southeast corner of Lot 1 in Wendy's International Inc. West Lake Avenue Subdivision, being a subdivision of parts of the east 1/2 of the southeast 1/4 of Section 38, aforesaid; Thence northerly along an easterly line of said Lot 1, 172.11 feet to a corner of said Lot 1; Thence easterly along a southerly line of said Lot 1, 98.05 feet to the most easterly corner of said Lot 1, said point being on the southwesterly line of Milwaukee Avenue; Thence southeasterly along the southwesterly line of Milwaukee Avenue to an intersection with the westerly extension of the southerly line of West Lake Avenue lying easterly of Milwaukee Avenue; Thence easterly along said last described southerly line and said line extended, to the place of beginning, in Cook County, Illinois.

Section 3: The Clerk of the Village of Glenview is hereby authorized and directed to record with the Recorded of Deeds of Cook County, Illinois, a certified copy of this ordinance, together with an accurate map of the territory annexed, attached hereto and made a part hereof and a document of annexation shall be filed with the County Clerk and the County Election Authority.

Section 4: This ordinance shall take full effect upon its passage and approval according to law.

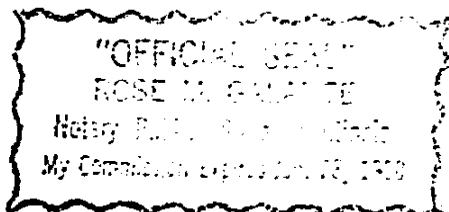
