leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of Seven thousand nine hundred sixty seven and 31/100ths Dollars.

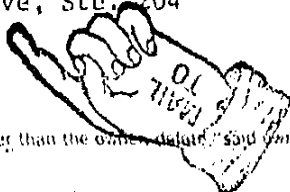

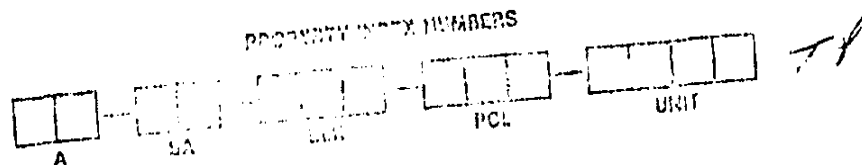
EXHIBIT A
