#### MORTGAGE, ASSIGNMENT OF RENTS AND SECURITY AGREEMENT

TO HAVE AND TO HOLD the Mortgaged Property, unto Lender, its successors and estions, forever, free from all rights and benefits under and by virtue of, and hereby releasing and war ing all rights under and by virtue of, the homestead exemption laws of the State of Illinois; for the purposes and uses herein set forth;

AND in connection with the foregoing, Borrower hereby agrees, covenants with, represents and warrants to Lender and any purchaser at any foreelosure sale, as of the date hereof and until the Indebtedness is paid in full and all other obligations of Borrower under this Mortgage or any of the other Loan Documents are performed in full, as follows:

1. Payment of Indehtedness. Borrower shall pay, promptly when due, each and every installment of principal and interest and any other indebtedness evidenced by or required to be paid pursuant to the Note; all charges, fees and other sums provided in the Loan Documents; and all other amounts, obligations and indebtedness secured by this Mortgage (collectively, the "Indebtedness") without demand, counterclaim, offset, deduction or defense and Borrower hereby waives all rights that now or hereafter are conferred by statute or otherwise to assert any such demand, counterclaim, offset, deduction or defense.

- 2. Fille to Mortgaged Property. Borrower has good and indefensible title to the Mortgaged Property in fee simple; it has a good and lawful right and full power to sell, mortgage or convey the Mortgaged Property and to encumber the same in the manner and form set forth herein; the Mortgaged Property is free and clear of all easements, restrictions, leases, liens and encumbrances whatsoever (and any claim of any other person thereto) except for those permitted encumbrances listed on Exhibit II attached hereto and incorporated herein ("Permitted Encumbrances"); and that it owns and will own all fixtures and articles of Personal Property now or hereafter affixed to or used in connection with the Real Estate, including any substitutions or replacements thereof, except as otherwise specifically disclosed to and consented to by Londer, free and clear of flors and claims. - d. Compliance with Laws. - (b) <u>Documentary Stamps</u>. - (c) Flood Insurance.
