

Assessment Roll. It appearing to the court that the first installment is in collection and the amount to be abated, \$5,850.82 should be credited by abating the entire remaining amount (10th) installment and 33-1/3% of the ninth (9th) installment contained in the

The court further finds that the said improvement has been completed in substantial conformity with the ordinance providing therefore, that the total amount assessed and as originally confirmed in the amount of \$47,488.00, exceeds the cost of the work, including labor and materials of \$33,644.00, engineering and inspection fees of \$4,602.10, the lawful expense attending the making, laying and collection of the assessment of \$2,281.76, and the amount estimated to be required to pay accruing interest on bonds and vouchers of \$1,086.82, by the sum of \$5,850.82; and

IT IS HEREBY ORDERED AND ADJUDGED that the application for confirmation and for approval of the final certificate of cost is sufficient in all respects, that notices of this hearing as prescribed by law have been published and given in the manner required by law.

This cause coming on to be heard on the petition of the Village of North Riverside for approval of a certificate of cost and completion of an improvement described in the Ordinance passed on February 1, 1988, by the corporate authorities of said municipality, the said Ordinance having been duly passed upon recommendation of the Board of Local Improvements after due notice and publication thereof and the holding of the necessary public hearings, the court having received and confirmed the Assessment Roll and Report prepared by the Commissioner duly appointed in said matter, and proper notice having been given to all parties concerned of the respective proceedings in this court, and this court having examined the Certificate of Cost and Completion showing that said improvement has been completed substantially as provided for in the above-described ordinance;
