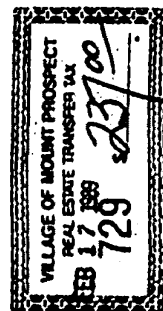
THIS INDENTURE, Made this 1 day of January, 1989

Meridian, in Cook County, Illinois.

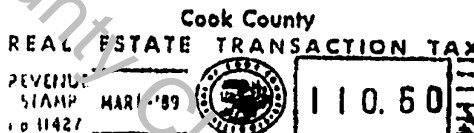
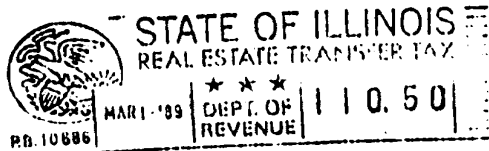
