

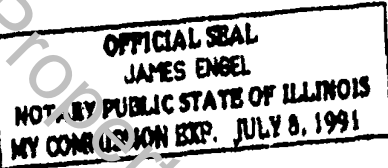

THAT PART OF THE WEST 1/2 OF THE NORTHWEST 1/4 OF SECTION 22, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, BOUNDED AND DESCRIBED AS FOLLOWS: BEGINNING AT A POINT IN THE CENTER LINE OF WILLOW ROAD, 120 FEET SOUTHEASTERLY MEASURED AT RIGHT ANGLES, FROM THE CENTER LINE BETWEEN THE TWO MAIN TRACKS, OF THE CHICAGO AND NORTHWESTERN RAILWAY COMPANY; THENCE NORTHEASTERLY PARALLEL WITH SAID CENTER LINE A DISTANCE OF 700.0 FEET TO A POINT, THENCE NORTHWESTERLY AT RIGHT ANGLES TO THE LAST DESCRIBED COURSE A DISTANCE OF 58.49 FEET TO A POINT DISTANCE 55.0 FEET SOUTHEASTERLY, MEASURED AT RIGHT ANGLES, FROM THE MOST SOUTHEASTERLY OR EASTBOUND TRACK; THENCE SOUTHWESTERLY PARALLEL WITH SAID MAIN TRACK CENTERLINE A DISTANCE OF 740.93 FEET TO A POINT ON THE CENTER LINE OF WILLOW ROAD; THENCE EASTERLY ALONG SAID CENTER LINE OF WILLOW ROAD TO THE POINT OF BEGINNING, ALL IN COOK COUNTY, ILLINOIS.
