NOTES

- 3. A corporation cannot act as its own registered agent.
- If the registered office is changed from one county to another, then the corporation must file with the recorder of reeds of the new county a certified copy of the articles of incorporation and a certified copy of the relement of change of registered office. Such certified copies may be obtained ONLY from the Socretary of State.
- Any change of registered agent must be by resolution adopted by the board of directors. This statement must then be signed by the President (or vice-president) and by the Secretary (or an assistant secretary).
- Corporation Department from 322 Corpor The registered agent may report a change of the registered office of the corporation for which he 6. or she is registered agent. When the agent reports such a change, this statement must be signed by the registered agent.
