

The South 225 feet of the North 331 feet of the East 153.56 feet and the South 282.38 feet of the North 388.38 feet of the West 95 feet of Block 71 in Chicago Heights in the Southwest quarter of Section 21, Township 35 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois.

PARCEL 2:

The South 175 feet of the West 120 feet of Block 71 aforesaid except that part conveyed to Chicago Heights Terminal Transfer Railroad Company by deed recorded March 18, 1903, in Book 8172, page 271 as Document No. 3364211.

PARCEL 3:
