6. Charges; Liens. Borrower shall pay all taxes, assessments, charges, fines and impositions attributable to the property which may attain priority over this Mortgage, and leasehold payments or ground rents, if any. Borrower shall promptly

Borrower Not Released for purpose by Lynder Not a Wriver Extresion of the time for payment or modification of amortization of a sum secured by the self-secured shall not operate to release the liability of the original Borrower's successor in interest.
