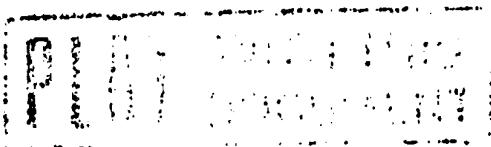



ORDINANCE NO. 89-2

ORDINANCE PERTAINING TO THE ANNEXATION OF  
TERRITORY TO THE FRANKLIN PARK PUBLIC LIBRARY DISTRICT

WHEREAS, the Franklin Park Public Library District is a library district organized and existing under the provisions of the Illinois Public Library District Act approved July 17, 1967, as amended; and

WHEREAS, Mannheim School District No. 83, Cook County, Illinois, and Leyden Community High School District No. 212 are included partially within the Franklin Park Public Library District; and

WHEREAS, the said Mannheim School District No. 83 and Leyden Community High School District No. 212 have annexed or otherwise included within their boundaries certain territory contiguous to the Franklin Park Public Library District, which territory is legally described on the Plat of Annexation attached hereto and made a part hereof as Exhibit A; and

WHEREAS, the territory described in Exhibit A is without local tax-supported public library service.

NOW, THEREFORE, Be It Ordained by the Board of Library Trustees of the Franklin Park Public Library District, Cook County, Illinois, as follows:

Section 1: That the territory described in Exhibit A attached hereto shall be and is hereby annexed into the domain of the Franklin Park Public Library District, subject to the provisions for referendum contained in §2-8(2) (par. 1002-8(2)) of Chapter 81, Illinois Revised Statutes (1987).

Section 2: Within fifteen (15) days of the passage of this annexation Ordinance the Secretary of this Library District shall send notice of the adoption hereof, a copy of the map showing the boundaries of the territory to be annexed and a copy of the text of the notice to be published pursuant to §3 of this Ordinance, to the President of the Board of Library Trustees of each public library with territory within one (1) mile of the territory to be annexed

Section 3: This Ordinance shall be published within fifteen (15) days after its adoption as provided by law and shall be effective within thirty (30) days after such publication; provided that if a petition signed by:

- (a) 289 or more voters of the Franklin Park Public Library District; or
- (b) 1 or more voters of the territory to be annexed; or
- (c) 290 or more voters of both the Franklin Park Public Library District and the territory to be annexed

is filed by February 24, 1989 (i.e., within thirty (30) days after the publication of this Ordinance), then the question of whether this Ordinance shall become effective shall be submitted to the voters of the Franklin Park Public Library District or the voters of the territory to be annexed, or the voters of both the Franklin park Public Library District and the territory to be annexed at the General Election to be held on November 7, 1989. The Secretary of the Board of Library Trustees of the Franklin Park Public Library District will provide a petition form to any
