GENERAL DIRECTORIAL POLICIES AND PRACTICES

THAT WHEREAS the MacFarlans are duly authorized to the Westward upon an amount of \$152,000.00 on the maximum principal sum of INDIAN FIFTEEN THOUSAND DOLLARS AND NO⁰ 152,000.00; THE MAXIMUM PER ANNUM RATE OF INTEREST ON THIS NOTE WILL NOT EXCEED 12%.

DOLLARS \$1 payable to the order of and delivered to the Mortgagor on and by which date the Mortgagor promises to pay the said principal sum and interest as follows: principal and interest (applied first to accrued interest, then to principal) due monthly in the full amount of principal and interest outstanding at the option of Mortgagor, in the maximum amount of the greater of two percent (2%) of the amount of principal and interest outstanding, all accrued interest outstanding to \$10,000, with the same balance of principal and interest due six (6) years from the date hereof, with interest accruing on the principal balance outstanding from time to time at the rate per annum referred to herein and in the Note as the "Legal Rate," which is the "Prime Rate" (described below) plus, whichever of the following percentages is then applicable (such percentages being adjusted as and when changed): ~~in NO percentage~~ during periods that the principal balance is less than \$15,000, or ~~in NO percentage~~ during periods that the principal balance is less than \$15,000 or greater than \$25,000, and in ~~in NO percentage~~ during periods that the principal balance is \$25,000 or greater, with the term "Prime Rate" being the rate of interest denoted at such time in the "Money Rates" section of *The Wall Street Journal* (adjusted quarterly), and all of said principal and interest as made payable at such place as the holders of the Note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of the Mortgagor.

at such place as the holders of the Note may from time to time designate, and in such manner as to effect payment in full of the principal amount of the Note, and the interest thereon, and all other amounts due under the Credit Agreement.

NOW, THEREFORE, the Mortgagor to secure the payment of the said principal sum of money, and said interest in accordance with the terms, provisions and limitations of this Mortgage, the Credit Agreement and the Note, and any extensions or renewals thereof, and the performance of the covenants and agreements contained herein and in the Credit Agreement, and also in consideration of the sum of One Dollar in hand paid, the receipt of which is hereby acknowledged, do by these presents MORTGAGE AND WARRANT unto the Mortgagor, and the Mortgagor's successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, whereof being and being in the CITY OF CHICAGO, COUNTY OF COOK and STATE OF ILLINOIS, to wit:

TOGETHER with all improvements, tenements, fixtures, and appurtenances thereto belonging and all rents, issues and profits thereof for so long and during all such times as Mortgagors may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondary) and all apparatus, equipment or articles now or hereafter thereon or thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether implemented or centrally controlled), and ventilation, including (without restricting the foregoing), screens, windows, shades, storm doors and windows, floor coverings, inside beds, swin g, j, seats and water heaters. All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed on the premises by Mortgagors or their successors or assigns shall be considered an continuing part of the real estate.

TO HAVE AND TO HOLD the premises unto the Mortgagee and the Mortgagee's successors and assigns forever, for the purpose set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits do hereby expressly release and waive.

THIS MORTGAGE is subject to the following described first mortgage or trust deed (hereinafter "First Mortgage") the holder thereof being hereinafter referred to as the "First Mortgagor".

Final Summary Statement

THIS MORTGAGE secures not only existing indebtedness but also future advances under the aforementioned Note and Credit Agreement made within twenty (20) years from the date hereof to the same extent as if such advances were made on the date hereof although there may be no advance on the date hereof and although there may be no advance thereafter.

THE MINUTEMEN HEREBY JOINTLY AND SEVERALLY COVENANT AND AGREE AS FOLLOWS:

- THE BORROWERS HEREBY AGREE AND STIPULATE AS FOLLOWS: As a condition precedent to the making of the Note:

3. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to the Mortgagee duplicate receipts therefor. To prevent default hereunder, Mortgagors shall pay in full

4. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire, lightning and windstorms, under policies providing for payment by the insurance companies of monies sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness so secured heretofore and any indebtedness superior hereto under the First Mortgage, all in companies reasonably satisfactory to the Mortgagor and the First Mortgagor, under insurance policies payable, in case of loss or damage, to Mortgagor and First Mortgagor as their interests shall appear, to be evidenced by the standard mortgage clause to be attached to each policy (providing that the same shall not be terminated except upon ten (10) days prior written notice to Mortgagor, and shall deliver all policies, including additional and renewal policies, to the First Mortgagor at the time of issuance, showing amounts shall always exceed policies not less than ten (10) days prior to the respective date of expiration).

5. In case of default thereof by Mortgagor, Mortgagor may, but need not, make any payment or perform any act heretofore required of Mortgagors in any form and manner deemed expedient, and may, but need not make full or partial payment of ownership or interest on premises, or taxes, including, without limitation, the First Mortgage and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeme from any tax sale or forfeiture affecting said premises or contest any tax or assessment. All money paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other money advanced by Mortgagor to protect the premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the Loan Rate. Inaction of Mortgagor shall never be considered as a waiver of any right accruing to the Mortgagor on account of any default hereunder on the part of the Mortgagors.

6. The Mortgagor making any payment hereby authorized, relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title to claim thereof.

7. Mortgagors shall pay each item of indebtedness secured hereunder, both principal and interest, when due according to the terms hereof and of the Note and the Credit Agreement. At the option of the Mortgagor and without notice demand or presentation to Mortgagor, all unpaid indebtedness secured by this Mortgage shall, notwithstanding anything in the Note or in this Mortgage to the contrary, become due and payable immediately (a) if there shall occur a default in payment of any installment of principal or interest under the Note within fifteen (15) days of the due date therein provided; or (b) if a breach of any representation or warranty of Mortgagors herein contained shall occur; or (c) if a default shall occur and continue for three days in the performance of any other covenant or agreement of the Mortgagors herein contained; or (d) if there shall occur an "Event of Default" as defined in the Note; or (e) if there shall occur a "Default" as defined in the Credit Agreement.

8. When the indebtedness hereby secured shall become due, whether by acceleration or otherwise, Mortgagor shall have the right to foreclose the lien hereof. In any suit to foreclose the lien hereof, there shall be allowed and included as additional indebtedness in the decree for sale all expenditures and expenses which may be paid or incurred by or on behalf of Mortgagor for attorneys' fees, appraiser's fees, outlays for documentary and expert evidence, stenographers' charges, publication costs and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all such abstracts of title, title searches, and examinations, title insurance policies, Torrens certificates, and similar data and assurances with respect to title as Mortgagor may deem to be reasonably necessary either to prosecute such suit or to evidence to bidders at any sale which may be had pursuant to such decree the true condition of the title to or the value of the premises. All expenditures and expenses of the nature in this paragraph mentioned shall become so much additional indebtedness secured hereby and immediately due and payable, with interest thereon at the Loan Rate, when paid or incurred by Mortgagor in connection with (a) any proceeding, including probate and bankruptcy proceedings, to which the Mortgagor shall be a party, either as plaintiff, claimant or defendant, by reason of this Mortgage or any indebtedness hereby secured; or (b) preparation for the commencement of any suit for the foreclosure hereof after accrual of such right to foreclose whether or not actually commenced; or (c) preparations for the defense of any actual or threatened suit or proceeding which might affect the premises or the security hereof.

9. Subject to any prior rights of the First Mortgagor, the proceeds of any foreclosure sale of the premises shall be distributed and applied in the following order of priority: First, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding paragraph hereof; second, all other items which under the terms hereof constitute secured indebtedness additional to that evidenced by the Note, with interest thereon as herein provided; third, all principal and interest remaining unpaid on the Note and Credit Agreement; fourth, any overplus to Mortgagor, their heirs, legal representatives or assigns, as their rights may appear.

10. Upon or at any time after the filing of a complaint to foreclose this Mortgage the court in which such complaint is filed may appoint a receiver of said premises. Such appointment may be made either before or after sale, without regard to the solvency or insolvency of Mortgagor at the time of application for such receiver and without regard to the then value of the premises or whether the same shall be then occupied as a homestead or not, and the Mortgagor may be appointed as such receiver. Such receiver shall have power to collect the rents, issues and profits of said premises during the pendency of such foreclosure suit and, in case of a sale and a deficiency, during the full statutory period of redemption, whether there be redemption or not, as well as during any further times when Mortgagor, except for the intervention of such receiver, would be entitled to collect such rents, issues and profits, and all other powers which may be necessary or are usual in such cases for the protection, possession, control, management and operation of the premises during the whole of said period. The court from time to time may authorize the receiver to apply the net income in his hands in payment in whole or in part of: (a) The indebtedness secured hereby, or by any decree foreclosing this Mortgage, or any tax, special assessment or other lien which may be or become superior to the lien hereof or of such decree, provided such application is made prior to foreclosure sale; and (b) the deficiency in case of a sale and deficiency.

11. No action for the enforcement of the lien or of any provision hereof shall be subject to any defense which would not be good and available to the party interposing same in an action at law upon the Note hereby secured.

12. The Mortgagor shall have the right to inspect the premises at all reasonable times and access thereto shall be permitted for that purpose.

13. If the payment of the indebtedness secured hereby or any part thereof be extended or varied or if any part of the security be released, all persons now or at any time thereafter liable therefor, or interested in said premises, shall be held to assent to such extension, variation or release, and their liability and the lien and all provisions hereof shall continue in full force, the right of recourse against all such persons being expressly reserved by the Mortgagor, notwithstanding such extension, variation or release.

14. Under the Credit Agreement, Mortgagor has agreed to cause this Mortgage to be released at its expense (including recording fees and otherwise) whenever this Mortgage no longer secures any indebtedness under the Note or Credit Agreement.

15. Mortgagors agree that they shall not cause, suffer or allow the conveyance, sale, lease, exchange, mortgage (other than this Mortgage or the First Mortgage), encumbrance (including, without limitation, mechanic's liens), attachment or other transfer or disposition of the premises or any part thereof, whether voluntary or involuntary by operation of law, without the prior written consent of Mortgagor and any such unpermitted transfer or other disposition shall constitute a default hereunder and, as provided herein, Mortgagor may thereupon, without notice, demand or presentation to Mortgagor declare all indebtedness secured hereunder to be immediately due and payable and may foreclose the lien hereof.

16. This Mortgage and all provisions hereof, shall extend to and be binding upon Mortgagor and all persons claiming under or through Mortgagor, and the word "Mortgagor" when used herein shall include all such persons and all persons liable for the payment of the indebtedness or any part thereof, whether or not such persons shall have executed the Note, the Credit Agreement or this Mortgage. The word "Mortgage" when used herein shall include the successors and assigns of the Mortgagor named herein and the holder or holders, from time to time, of the Note secured hereby.
