NOTICE OF LIEN

That the balance of the aforesaid charges due, unpaid and owing pursuant to the aforesaid Declaration after allowing all credits, is the sum of \$1,185.20 through March, 1989. Each monthly assessment thereafter is in the sum of \$332.00 per month.
