## FIRST AMENDMENT TO DECLARATION OF CONDOMINIUM FOR WESTON COURTYARD MANOR HOMES, A CONDOMINIUM

This Amendment To The Declaration of Condominium for Weston Courtyard Manor Homes made and entered into this 23rd day of March, 1989 by Harris Bank, Roselle, a corporation of Illinois, not personally, but as Trustee under Trust Agreement dated August 1, 1988 and known as Trust No. 12722 (the "Trustee"):

#### WITNESSETH

WirPlAS, by the Declaration of Condominium recorded in the Office of the Recorder of Deeds of Cook County, Illinois as Document No. 38474850 (the "Declaration") the Trustee submitted certain real property to the Condominium Property Act of the State of Illinois (the "Act"), said condominium being known as Weston Courtyard Manor Homes (the "Condominium"); and

WHEREAS, under the Declaration the right is reserved in the Trustee among others to annex and add portions of the Development Area described on Exhibit E to the Declaration, to the Parcel and thereby add said real estate to the Condominium.

NOW, THEREFORE, the Trustee for the rurposes above set forth, hereby declares that the Declaration is amended as follows:

- 1. Exhibit A attached to the Declaration describing the land submitted to the Act is hereby amended and supersected in its entirety by Exhibit A attached hereto which sets forth the amended light description of the Parcel to include the Added Property.
- 2. The Added Property, which is described on Page 1 of Exhibit B attached hereto, is hereby added to the Parcel as provided in Paragraph 22 of the Declaration, and is hereby submitted to the provisions of the Act as part of the Condominium in accordance with, and shall be deemed to be governed in all respects by, the terms and provisions of the Declaration.
- 3. The Plat, attached to the Declaration as Exhibit B showing the boundaries of the Parcel and delineating and describing the Units contained herein is hereby further amended and supplemented by the substitution of Page 1 and the addition of Pages 2, 3, 4 and 5 of Exhibit B attached hereto showing the boundaries of the Added Property and of the entire Parcel as amended and delineating and describing the additional Units contained in said Added Property.

- 4. Dhibit C attached to the Declaration, as amended, setting forth the percentages of the undivided interests in the Common Elements appurtenant to each Unit described in Exhibit C prior to this First Amendment are hereby reduced to the respective percentages set forth in Exhibit C as hereby amended, and said Exhibit C attached to the Declaration, as amended, is hereby further amended and superseded in its entirety by Exhibit C attached hereto.
- 5. The additional Common Elements are hereby granted and conveyed to the grantees of Units heretofore conveyed all as set forth in the Declaration.
- 6. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.

It is hereby expressly understood and agreed by and between the parties hereto, anything herein to the contrary notwithstanding, that each and all of the representations, convenants, undertakings, and agreements herein made on the part of the Tristee are nevertheless each and every one of them made and intended not as rersonal representations, covenants, undertakings and agreements by the Tristee or for the purpose of with the intention of binding said Trustee personal'n', but are made and intended for the purpose of binding only that portion of the trust property specifically described herein, and this instrument is execu'ed and delivered by said Trustee not in its own right, but solely in the elercise of the powers conferred upon it as such Trustee, and that no personal liability or personal responsibility is assumed by nor shall at any time be asserted or enforceable against Harris Bank, Roselle or any of the beneficiaries under said Trust Agreement on account of this instrument or on account of any representation, covenant, undertaking or agreement of the said Truster in this instrument contained, either expressed or implied, all such personal liability, if any, being expressly waived and released. It is understood and agreed by the parties hereto, anything to the contrary notwithstanding, that the Trustee will act only on the direction of the beneficiaries.
