THIS INDENTURE made March 23, 1989, between Thomas Stewart and Virginia L. Stewart, his wife, *** HERITAGE BANK OF COUNTRY CLUB HILLS an Illinois corporation doing business in C. C. Hills, Illinois, herein referred to as Trustee, witnesseth: THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the Installment Note herein after described, said legal holder or holders being herein referred to as Holders of this Note, in the principal sum of THIRTY SIX THOUSAND FOUR HUNDRED AND 00/100 (\$36,400.00) **** Dollars, evidenced by one certain Installment Note of the Mortgagors of even date herewith, made payable to HERITAGE BANK OF COUNTRY CLUB HILLS

All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each installment unless paid when due shall bear interest at the rate of maximum allowed by law per annum, and all of said principal and interest being made payable at such banking house or trust company in C. C. Hills, Illinois as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of Heritage Bank of C.C.Hills, in said City, Country Club Hills.
