SUBORDINATION AGREEMENT

WHEREAS, on or about August 15, 1988 BANK OF RAVENSWOOD, as Trustee under Trust Agreement dated March 10, 1986 and known as Trust No. 25-7640, the Mortgagor, executed a Mortgage Security Agreement and Financing Statement ("MORTGAGE") to COLE TAYLOR BANK/FORD CITY, the "Mortgagee", which mortgage is to be recorded in the office of the Recorder of Deeds of Cook County, Illinois in the amount of \$1,250,000.00 against the Mortgagors interest in the real estate hereinafter referred to as the "Property", and which Property is legally described on Exhibit "A" attached hereto and made a part hereof; and

1988, SUBWAY RESTAURANTS, INC., hereinafter referred to as "Lessee" entered into a certain Lease, the "Lease", for parts of the Property with Mortgagor, wherein Lessee agreed to lease from Mortgagor part of the Property and pursuant to which Lease Lessee may have acquired some right, interest and claim in and to the Property; and

WHEREAS, as a material inducement to Mortgagee making the Mortgage to Mortgagor, Mortgagor represented to Mortgagee that the Lease is in full force and effect and that the Lease is not cancellable or voidable by Lessee; and

WHEREAS, Lessee is willing to subordinate its interest and claim in the Property to the lien of COLE TAYLOR BANK/FORD CITY which is to be created by the Mortgage.

NOW, THEREFORE, the undersigned in consideration of the premises and of the sum of ONE DOLLAR (\$1.00) paid to the undersigned, receipt of which is hereby acknowledged, does hereby covenant and agree that:

- (i) The right, interest and claim of Jessee, its successors and assigns, is, shall be and shall remain at all times subject to and subordinate to the lien of the Mortgage to said COLE TAYLOR BANK/FORD CITY, and for all advances, extensions or renewals made or to be made under the provisions of said Mortgage, or on the Note secured thereby and for all other purposes specified therein.
- (ii) That the Lease is in full force and effect, there is no default on the part of the Landlord and that anything to the contrary contained in the Lease notwithstanding that Lessee will take possession of the premises when construction is substantially completed (as said term is defined in the Lease) on which date rent payments will commence and the Lease term will begin and that in no event will Lessee cancel or void this Lease
