- The General Partners hereby agree that the Partnership is dissolved and terminated and that the Original Agreement, as amended, pursuant to which the Partnership has previously operated, is cancelled and terminated, all effective as of December 31 , 1988.
- The Partners hereby agree to execute and file any and all additional documents and instruments in furtherance of the dissolution and termination of the Partnership.
