#### ASSIGNMENT OF TITLE

The Company, for itself, its successors, and assigns, hereby assigns and conveys to owners, their heirs, successors, and assigns, all right, title and interest it may have, or may hereafter acquire, pursuant to Chapter 24, Section 11-91-1, et seq., Ill. Rev. Stats., or otherwise, upon vacation thereof by the City Council of the City of Park Ridge, in

the north half of vacated Avondale Avenue, north of lots 1, 2 and the east 10.05 feet of lot 3, in Nate Reed's Resubdivision of lots 25-29 in Oakton Manor 2nd Addition, being a subdivision in the east half of the northeast quarter of the northwest quarter of Section 27, Township 41, Range 12 East of the Third Principal Meridian, in Cook County, Illinois

and agrees to deliver to owners a quitclaim deed for its interest in said parcel upon vacation thereof. Owners agree to pay the Company \$600.00 for preparation of the quitclaim deed.
