In addition to the agreement and provision of said Hortgage, the undersigned agree as follows:

- 1. Any provisions of said Mortgage which are inconsistent with the provisions of this Rider are hereby amended or negated to the extent necessary to conform said Hortgage to the provisions of this Rider.
- 2. In order to provide for the payment of taxes and other annual charges upon the property securing the indebtedness, Hortgagor shall pay to Portgagee on the first day of each month commencing on the 1st day of 1989, one twelfth of the estimated annual Real Estere tax bill (based on the then most recent tax bill). Nortgages shall be responsible for applying those funds to the tax bills <u>O</u>gr<u>il</u> thereafter due. There such funds are sufficient, Hortgagor upon Hortgagee's demand, sigli immediately pay to Hortgagee the balance necessary to pay those tam oills. At Nortgagor's request from time to time, Mortgagee shall provide for tangor with evidence that such taxes and insurance have been paid.
- 3. In the event Mortgagor, his helrs, executors or administrators, assign, convey, contract to convey or otherwise dipose of the mortgaged premises or any part thereof without a prior consent in writing of the Mortgagee or in case of Mortyagor's fallure to maintain beneficial membership status in good standing with the Hortgagee, Hortgagee may, at his discretion, declare the entire in the edness to be immediately due and payable, without notice to Hortgagors (which is hereby expressly waived by Mortgagors) and upon such declaration the entire indebtedness shall be immediately due and payable.
- 4. The fallure of Mortgagee to exercise Mortgagee's option for acceration of maturity and/or foreclosure to fowing any default under the Mortgage, or to exercise any other option cranted Mortgagee hereunder in any one or more instances, or the acceptance by Mortgagee of partial payment hereunder shall constitute a walver of any such default, except as maybe provided by law, nor extend or affect the wrace period, if any, but such option shall remain continuously in force. Acceleration of maturity once claimed hereunder by Hortgagee may, at the option of Hortgagee, be rescinded by written acknowledgement to that effect by Mortgagee, but the tender and acceptance of partial payment alone shall not in any way effect or rescind such acceleration of maturity, except as provided by law, nor extend or affect the grace period, it and
- 5. Mortgagors covenant and agree that they will not crea*c* or permit to be created any lien, inferior or superior to the lien of this Mortgage, without having first obtained a written approval of the Nortgagee.
- 6. Mortgagor agrees to pay all costs of collection, including a reasonable attorney's fee, in case the principal of the installment Note secured by this Mortgage, or any payment on the principal or interest thereon is not paid at the respective maturity thereof, or to pay all costs, including reasonable attorney's fee, in case it becomes necessary to protect the security thereof, whether a suit be brought or not.
