AN ORDINANCE

PROVIDING FOR THE MAKING OF A LOCAL IMPROVEMENT IN AND FOR THE VILLAGE OF NORTH RIVERSIDE, COOK COUNTY, ILLINOIS SPECIAL ASSESSMENT NO. 70

NCW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of North Riverside, Cook County, Illinois, as follows:

SECTION 1. That a local improvement shall be made in the Village of North Riverside, Cook County, Illinois, the nature, character, locality and description of which improvement is as follows: The improvement of the roadway of Harlem Avenue from 22nd Street (Cermak Road) to 16th Street, by excavating and grading, for pavement widening, and the construction of new combination concrete curb and gutter, bituminous aggregate base course, bituminous concrete surface course, the installation of ornamental street lights, and all other work incidental to the excavating and grading for a complete improvement. Plans for the improvements showing the type of construction and all other necessary details are on file with the Secretary of the Board of Local Improvements and are entitled "Village of North Riverside, Roadway Improvement, Special Assessment No. 70, Roadway of harlem Avenue from 22nd Street (Cermak Road) to 16th Street."

(Balance of specifications and plans are on file with the Village Clerk North Riverside, 2401 S. DesPlaines Avenue, North Riverside, Illinois, 60546, and may be inspected at any time during normal business hours).

SECTION 2: That the recommendation of the Board of Local Improvements of the Village of North Riverside, providing for the improvement, and the estimate of the cost thereof made by the President of the Board of Local Improvements, both

SECTION 3: The said improvement shall be made and the cost thereof which is estimated to be \$390,656.00 shall be paid for by special assessment in accordance with Article 9, Division 2, Chapter 24 of the Illinois Revised Statutes, as amended, and that the sum of \$20,928.00 which is included in the whole cost shall be applied toward the payment of lawful costs and expenses incurred in making, levying and collecting the assessment for said improvement; that the sum of \$29,325.00 and \$3,215.00 which is included in the whole cost shall be applied toward the cost of singlineering and inspection services and material proportioning and testing and that the sum of \$20,928.00 which is included in the whole cost, shall be used to create a reserve for possible deficiency in interest required to be paid on vouchers or bonds issued for making said improvement.

SECTION 5: That for the purpose of anticipating the collection of the installments of said assessment and upon written request of the holder or holders of all outstanding and unpaid vouchers issued in payment of work, the Village of North Riverside shall issue and deliver bonds to such voucher holder or holders in exchange for such vouchers. Said bonds shall be dated as of and draw interest from the date of their issuance, except when issued in exchange for vouchers issued for work done; in such latter case the bonds shall be issued in the amount of principal

Any monies collected on the first installment shall be first used to pay the costs, as provided by statute.

SECTION 6: The President of the Village of North Riversiae be and he is hereby directed to file a petition in the Circuit Court of Cook Courty. County Division, as provided by law in the name of the municipality, praying that steps may be taken to levy a special assessment for said improvement, in accordance with the provisions of this ordinance and in the manner prescribed by law.

SECTION 7: That all ordinances, or parts of ordinances, in conflict with this ordinance, be, and the same are hereby repealed.

The excavated material shall be removed from the site and the subgrade rolled and compacted to true form, line and grade as directed by the Engineer. The subgrade shall be rolled with a self-propelled roller approved by the Engineer, and no base shall be laid until the subgrade is approved.
