THIS MORTGAGE made this 7th day of April, 1989, between First Bank of Schaumburg, Not Personally but as Trustee U/I/A dated 2/23/89 and known as Trust No. 89-1057. 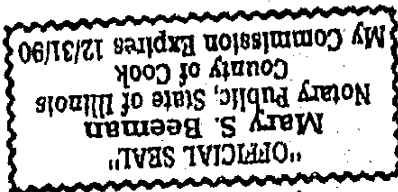
