All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal; provided that the principal of each instalment unless paid when due shall bear interest at the rate of **-14.00-** per cent per annum, and all of said principal and interest being made payable at such banking house or trust company in
