

Excerpts From Internal Revenue Cour

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or retuses to pay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition thereto) shall be a tien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the lien imposed by section 8321 shall arise at the time the assessment is made and shall continue until the itability for the amount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Michanic's Lienors, And Judgment Lien Creditors. — The Ren Imposed by section 8321 shall not be valid in galants any purchaser, holder of a security interest, mechalig's Hanor, or judgment lien creditor until notice thereof which repers the requirements of subsection (f) has been filed by the Secretary.

(n Place For Filing Notice; Form.—

(1) Place For Filing - The notice referred to in subsection (a) shall be filed -

(A) Under State Laws

(i) Real Property - in the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; and

(iif Personal Property - in the case of personal property, whether tangible or intengible, in one office within the State (or the county, or other governmental auditivision), as designated by the laws of such State, in which the property subject to the item is situated;

(8) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has find by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia - In the office of the Recorder of Deeds of the District of Columbia, if the property subject to the lien is situated in the District of Columbia.

(2) Situs Of Property Subject To Lien - For purposes of paragraphs (1) and (4), property shall be deemed to be situated-

(A) Real Property - in the case of real property, at its physical location; or

(8) Personal Property - in the case of general property, the residence of the taxon or at the time the notice of lies is filed.

For purpose of paragraph (2) (8), the residence of a corporation or parti erable shall be deemed to be the place at which the principal execute entities of the business is located, and the residence of a law even whose residence is without the United States shall be one ned to be in the District of Columbia.

(3) Form - The .orm and content of the notice referred to in subsection (a) shall be prescribed by the Secretary. Such notice and a valid notwithstanding any notice of iden.

Note: See section 6323(b) for protection for certain interests even though notice of lien imposed by section 6321 is filed with respect to:

- 1. Securities
- 2. Motor vehicles
- 3. Personal property purchased at retail
- 4. Personal property purchased in casual sale
- 5. Personal property subjected to possessory lien 8. Real property tax and special assessment ilens
- Residential property subject to a mechanic's ilen for certain repairs and improvements
- 8. Attorney's liens
- 9. Certain insurance contracts
- 10. Passbook Ipans
- (B) Refling Of Notice. For purposes of this section -
- (1) General Rule. Unless notice of the is refiled in the manner prescribed in paragraph (2) during the required refiling period, such notice of tien shall be treated as filed on the date on which it is filed (in accordance with subsection (ii) after the expiration of such refiling period.
- (2) Place For Filling. A notice of fien reflied during the required refilling period shall be effective only.

(A) if

- (I) such notice of lien is refiled in the office in which the prior notice of lien was filed, and
- (ii) in the case of real property, the fact of refilling is entered and recorded in an index to the extent required by subsection (f) [4], and
- (B) In any case in which, 90 days or more prior to the date of a refilling of notice of lien under subparagraph (A), the

Secretary received written information (in the manner prescribed in regulations issued by the Secretary) concerning a change in the taxpayer's recidence, if a notice of such ties is also filled in accordance with subsection (f) in the State in which such residence is legaled.

(3) Required Reliting Period. — In the case of any notice of lies, the term "required reffling period" means—(A) the one-year period ending 30 days after the expiration of 6 years after the date of the assessment of the tax, and (B) the one-year period ending with the expiration of 8 years after the close of the preceding required reffling period for such notice of lies.

Sec. 6325. Release Of Lien Or Discharge Of Property.

- (a) Pelease Of Lien. Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day on which -
- (1) Liability Satisfied or Unenforceable The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unenforceable; or
- (2) Bend Accepted There is furnished to the Secretary and act up not by him a bond that is conditioned upon the payment of the "mount assessed, together with all inferent in respect thereof, within the time prescribed by law (including actions to of wich time), and that is in accordance with auch requirements to acting, to terms, conditions, and form of the fond and surelies the "an 2s may be specified by such regulations.

Sec. 6103. Confidentiality and Disclosure of Raturns and Return information.

- (k) Disclosure of Certain Returns and Return Information For Tax Administration Purposes.—
- (2) Disclosure of amount of putstanding (lien, if a notice of lien has been filed pursuant to section 6323(1), the amount of the outstanding obligation secured by such lien may be disclosed to any person who furnishes satisfactory written evidence that he has a right in the property subject to such lien or intends to obtain a right in such property.
