AN ORDINANCE VOLUNTARILY ANNEXING CERTAIN TERRITORY
TO THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, on April 12, 1989, the owner of record of the territory described in Section 2 hereinbelow and all of the electors residing therein, in conformance with Chapter 24, Section 7-1-8 of the Illinois Municipal Code, filed a voluntary verified annexation petition respecting said territory with the Clerk of the Village of Glenview requesting that said territory be annexed to the Village of Glenview.

WHEREAS, the corporate authorities of the Village of Glenview desire to assure that the territory described in Section 2 hereinbelow becomes and remains annexed as a part of the Village of Glenview, as desired by the owner and electors thereof; and

WHEREAS, adoption of the within Ordinance will assure annexation of the territory described in Section 2 hereinbelow in compliance with and pursuant to the applicable provisions of the Illinois Municipal Code;

NOW THEREFORE, be it ordained by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that:

Section 1: The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2: The Village of Glenview, pursuant to Chapter 24, Section 7-1-8, Illinois Revised Statutes (1987), hereby

annexes the territory legally described as:

THE EAST 143.80 FEET OF THE WEST 573.80 FEET, EXCEPT THE SOUTH 362.45 FEET THEREOF, OF THAT PART OF LOT 3 LYING IN THE SOUTHEAST 1/4 OF SECTION 20, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN SUPERIOR COURT PARTITION OF THE SOUTH 3/4 OF THE SOUTHEAST 1/4 AND THE EAST 10 ACRES OF THE SOUTH 76 RODS OF THE SOUTHWEST 1/4 OF SECTION 20, AFORESAID, IN COOK COUNTY, ILLINOIS.

Section 3: The territory described in Section 2 hereinabove is not within the corporate limits of any municipality and is contiguous to the present Village limits of the Village of Glenview.

Section 4: The sole owner and all of the electors residing on the territory described in Section 2 hereinabove have duly signed a voluntary verified annexation petition to annex said territory to the Village of Glenview. Said petition for annexation was filed with the Clerk of this Village on April 12, 1989.

Section 5: The President and Board of Trustees of the Village of Glenview have determined that annexation of the said territory is in the public interest and will promote the public health, safety and welfare of the Village of Glenview and its residents.

Section 6: A plat of the above described territory is hereby made a part of this Ordinance by attachment, and a certified copy of this Ordinance together with such plat shall be recorded with the Recorder of Deeds of Cook County, Illinois. The aforesaid plat is an accurate depiction of the above described territory.

Section 7: Proper notice to the Trustees of the Glenbrook Fire Protection District has been served in compliance with the provisions of Chapter 24, Section 7-1-1, Illinois Revised Statutes (1987). Proper notice has also been duly served on the Trustees of Northfield Township and the Highway Commissioner of Northfield Township. An affidavit with respect to notice to the Trustees of the Glenbrook Fire Protection District shall be recorded in accordance with statutory requirement.

Section 8: Every section and provision of this Ordinance shall be separable, and the invalidity of any portion of this Ordinance shall not affect the validity of any other portion of this Ordinance.

Section 9: This Ordinance shall take full effect upon its passage and approval according to law.


