AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO
THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, the corporate authorities of the Village of Glenview, have determined that annexation of certain territory in Cook County, Illinois, hereinafter described, is in the public interest and in the best interests of the Village of Glenview, and will promote the public health, safety and welfare of the Village and its residents; and

WHEREAS, the corporate authorities of the Village of Glenview, a home rule municipality, find that the following described territory is unincorporated territory containing less than 60 acres, and is wholly bounded by the village of Glenview.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that:

Section 1: The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2: The unincorporated territory containing less than 60 acres and wholly bounded by the Village of Glenview, legally described as:

THAT PART OF THE WEST 1/2 OF THE SOUTHEAST
1/4, SECTION 20, TOWNSHIP 42 NORTH, RANGE 12,
EAST OF THE THIRD PRINCIPAL MERIDIAN, COM-
MENCING AT A POINT ON THE NORTH LINE OF LOT
3, 573.80 FEET, EAST OF THE INTERSECTION OF

be and the same is hereby annexed to the Village of Glenview, Cook County, Illinois, pursuant to the provisions of Section 7-1-13 of the Illinois Municipal Code.

Section 3: The territory described in Section 2 hereinabove is not within the corporate limits of any municipality and is contiguous to the present Village limits of the Village of Glenview.

Section 4: The Clerk of the Village of Glenview is hereby authorized and directed to record with the Recorder of Deeds of Cook County, Illinois, a certified copy of this Ordinance together with an accurate map of the territory annexed, and a document of annexation shall be filed with the County Clerk and the County Election Authority.

Section 5: Proper notice to the Trustees of the Glenbrook Fire Protection District has been served in compliance with the provisions of Chapter 24, Section 7-1-1, Illinois Revised Statutes (1987). Proper notice has also been duly served on the Trustees of Northfield Township and the Highway Commissioner of Northfield Township. An affidavit with respect to notice to the Trustees of the Glenbrook Fire Protection District shall be recorded in accordance with statutory requirement.

Section 6: Proper notice in accordance with the statutory requirement was published in a newspaper of general circula-

tion within the territory to be annexed stating that annexation of the territory described in the notice was contemplated under Section 7-1-13 of the Illinois Municipal Code.

Section 7: Every section and provision of this Ordinance shall be separable, and the invalidity of any portion of this Ordinance shall not affect the validity of any other portion of this Ordinance.

Section 8: This Ordinance shall take full effect upon its passage and approval according to law.




