THIS INDENTURE, made APRIL 27, 1989 19, between DAVID A ALBERTS AND JANICE

E. ALBERTS, HIS WIFE, IN JOINT TENANCY

herein referred to as "Mortgagors," and SECURITY PACIFIC FINANCIAL SERVICES A DELAWARE, a corporation, herein referred to as TRUSTEE, witnesseth:

NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this trust deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, its successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in VILLAGE OF ALSIP, COUNTY OF COOK AND STATE OF ILLINOIS, to wit:

TO HAVE AND TO HOLD the premises unto the said Trustee, its successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.

This Trust Deed may not be assumed.

This trust deed consists of two pages. The covenants, conditions and provisions appearing on page 2 (the reverse side of this trust deed) are incorporated herein by reference and are a part hereof and shall be binding on the mortgagors, their heirs, successors and assigns.
