- 5. That Plaintiff by competent evidence, established that without cause or provocation on the part of Plaintiff, Defendant has been guilty of extreme and repeated mental cruelty.
- 6. That Plaintiff resides in Palatine, Illinois and that she is employed by Operations Service Systems.
- 7. That defendant resides in the marital home at 808 Lily Lane, Palatine, Illinois, and that he is receiving disability income.
